

PUBLICATION OF CONTRACT AWARDS FOR CONTRACT MANAGEMENT & VERIFICATION AGENCY (CMVA) AND INDEPENDENT VERIFICATION AGENCY (IVA) UNDER NIGERIA STATE HEALTH INVESTMENT PROJECT (NSHIP)

The National Primary Health Care Development Agency through the Nigeria State Health Investment Project (NSHIP) has finalised the procurement process for the engagement of Contract Management & Verification Agency (CMVA) and Independent Verification Agency (IVA) for the NSHIP States of Nasarawa and Adamawa. The consultants are expected to replace the foreign firm; Oxford Policy Management (OPM) whose contract has elapsed.

The CMVA will provide contract management and ex ante verification of services. The CMVA will support the delivery of the Minimum Package of Activities (MPA) and complimentary package of Activities (CPA).

The IVA will on the other hand, will carry out ex-post verification of validated quantity and quality of care for Health Centers and general Hospitals as recorded by the LGHA and HMBs. In addition, the IVA will carry out ex-post validation of performance framework assessments of the LGHAs and HMBs using approaches described in the project implementation manual (PIM)
