

TERMS OF REFERENCE FOR NATIONAL REPRODUCTIVE, MATERNAL, NEONATAL, CHILD, ADOLESCENT HEALTH AND NUTRITION (RMNCAH+N) TECHNICAL ASSISTANT FOR THE IMMUNIZATION PLUS AND MALARIA PROGRESS BY ACCELERATING COVERAGE AND TRANSFORMING SERVICES (IMPACT) PROJECT

A. Introduction:

The National Primary Health Care Development Agency (NPHCDA) is a parastatal of Nigeria's Federal Ministry of Health with the corporate goals to; control preventable diseases and eradicate polio, improve access to basic health services, improve quality of care, develop high-performing health workforce, strengthen the primary care institutions, partnerships, and community engagement.

The Multiphase Programmatic Approach (MPA) is an intervention by Government of Nigeria with a credit from the World Bank to strengthen primary health care to reduce Under-5 Mortality Rates (U5MR) using a Decentralized Facility Financing (DFF) Mechanism. The MPA has 3 phases, starting with an Immunization plus and Malaria Progress by Accelerating Coverage and Transforming Services (IMPACT) project. The IMPACT project is a large investment in the Nigeria health sector with ambitious targets for service improvements and health systems strengthening.

The project development objective of the IMPACT project phase of the MPA is to improve the utilization and quality of immunization plus (immunization, child, neonatal and maternal) and malaria services in selected states.

The project has 4 components; (1) Malaria Control; (2) Immunization plus; (3) Knowledge for Change; (4) Contingent Emergency Response Component (CERC) and will be implemented in a total of 20 states. 6 States of Abia, Borno, Ekiti, Imo, Lagos and Rivers, will implement component 1, on malaria control and 14 States of Adamawa, Bauchi, Benue, Delta, Ebonyi, Kaduna, Kano, Kogi, Kwara, Nasarawa, Oyo, Plateau, Sokoto and Yobe, will implement component 2, the immunization plus component of the project.

The project will be implemented by 2 Project Implementing Units (PIUs) at the Federal level situated at the National Malaria Elimination Program (NMEP) for components 1 and 3 and at the National Primary Health Care Development Agency (NPHCDA) for components 2 and 3. Similarly, at the State level, the PIUs at State Malaria Elimination Program (SMEP) will implement component 1 in the Malaria States and State Primary Health Care Boards (SPHCBs), component 2 in the Immunization Plus States.

The immunization plus component of the project, in addition to routine immunization services, includes high impact and innovative RMNCAH+N (Reproductive, Maternal, Neonatal, Child, Adolescent Health and Nutrition) interventions that will focus on improving availability, uptake, and quality of perinatal and postnatal services, which will contribute to addressing neonatal mortality and as a continuum, improve under-five morbidity including malnutrition, and under-five mortality.

B. Objective of the Technical Assistant position:

The core objective of this assignment is to provide technical and operational support to the IMPACT PIU and facilitate the implementation of the project according to the approved annual work plans.

The National RMNCAH+N TA will help ensure reduction in under-five mortality rates (U5MR) especially as it relates to RMNCAH+N in the IMPACT project states overall and support lagging states in implementing innovational interventions that will promote transformational change in their coverage rates within the shortest possible time. This will be done in accordance with the principles of result-based management and the TA's payment will be prorated based on improved Programme Assessment for Performance management and Action (PAPA) LQAS and other programmatic results.

C. Overall Responsibilities:

The National RMNCAH+N TA will report to the National IMPACT Project Manager through the NEMCHIC Project Manager.

The TA shall function as a core member of the national IMPACT PIU, providing technical support in the strategic execution and achievement of IMPACT project goals and objectives and shall work with the IMPACT RMNCAH+N Case Manager under the supervision of the NEMCHIC Project Manager to ensure implementation of the RMNCAH+N component of the IMPACT project.

He/she will work with all the stakeholders in the RMNCAH+N space including development partners and community structures to achieve transformational impact in reducing U5MR. This includes supporting the national IMPACT project management on a robust mechanism for evaluation of RMNCAH+N program performances towards ensuring program goals are met and closely interface with the NEMCHIC.

He/ She will collaborate/work with the National Immunization TA to ensure joint planning and implementation of PHC strengthening interventions that cut across Immunization and RMNCAH+N service improvement.

The TA will also support the NPHCDA and the World Bank task team in monitoring and supervision of the project at the state level, contribute to documenting lessons in implementation, and ensure high quality ongoing reporting of project's progress.

D. Specific responsibilities:

Through a transparent and competitive recruitment process, selected individuals shall perform the following roles and responsibilities:

1. Report to the National IMPACT Project Manager through the NEMCHIC Project Manager.
2. Shall function as a core member of the national IMPACT project team and provide key operational and implementation support:

- i. Provide support to the NPIU to develop and update respective annual work plans for the national to complete agreed project activities.
 - ii. Facilitate implementation of actions within the approved annual work plan for completion of planned activities.
 - iii. Provide support to ensure that all communication and guidance provided by the National Project Implementation Unit (NPIU) in NPHCDA and the World Bank on project intervention is addressed and responded to for robust project implementation.
 - iv. Ensure all communication from the NPIU and the World Bank on technical aspects are appropriately communicated to all cadres of officials for robust project implementation.
 - v. Coordinate with technical teams deployed for implementation of project, SPIU, NPHCDA, and the World Bank to ensure transparent and smooth completion of approved work programs.
 - vi. Support the NPIU in their role of preparing and updating progress reports of the project on an ongoing basis and assist state in documentation of progress.
 - vii. Undertake periodic supervision visits to project sites with designated officials of the NPIU and through field visit reports, provide feedback to NEMCHIC and National IMPACT Project Manager on qualitative and quantitative achievement of project activities.
 - viii. Identify early bottle necks in project implementation and flag to NPIU for subsequent engagement with NERICC, NEMCHIC, IMPACT states, World Bank, and other relevant stakeholders and together with the team, devise strategies/mechanisms/solutions to resolve the bottlenecks for fast tracked project implementation.
3. Shall provide technical support to the National RMNCAH+N Coordination Platform in the strategic execution and achievement of the platform's goals and objectives:
- i. Design and implement knowledge transfer plan.
 - ii. Improve detection and responsiveness in the resolution of RMNCAH+N service gaps.
 - iii. Strengthen coordination, leadership, and accountability.
 - iv. Increase RMNCAH+N data visibility, quality and use for action at all levels.
 - v. Improve awareness and promote community involvement in interventions to reduce maternal and child mortality.
 - vi. Prepare report of activities and present at the weekly briefing meeting of the national IMPACT project.
 - vii. Share report of activities with the National RMNCAH+N Coordination Platform on weekly basis copying the national and state IMPACT Project Managers.
4. Program Coordination and Implementation:
- i. He/she will work with **all** the stakeholders in the RMNCAH+N space, including development partners and community structures, to achieve transformational impact in increasing the coverage of RMNCAH+N interventions and reducing the burden of maternal and child mortality. This includes the management of a robust mechanism for RMNCAH+N program performance, ensuring program goals are met.

- ii. Shall support the States through the IMPACT team in establishing a mechanism for PHC service integration.
 - iii. Shall be a key member of the National RMNCAH+N Coordination Platform and attend meetings of the RMNCAH+N technical working groups and other relevant technical meetings, updating the NEMCHIC PM on issues pertaining to RMNCAH+N service delivery and uptake at PHC and community levels.
 - iv. Support and drive the RMNCAH+N teams to spend considerable time in LGAs, especially those LGAs that are lagging in Antenatal Care, Skilled Birth Attendant and Post Natal Care rates (resulting from diagnostic analysis), working with LGA staff and health workers to improve RMNCAH+N services.
 - v. Work closely with management and members of the coordination platform to ensure timely delivery on program activities.
5. Partnerships Coordination
- i. Participate in discussions or correspondences with development partners and other stakeholders in the RMNCAH+N space.
 - ii. Maintain quality interactions with national, state, and international stakeholders supporting the RMNCAH+N programs.
 - iii. Support the team lead of the state RMNCAH+N coordination platform on administrative activities related to the platform, including closely liaising with other relevant departments and programs in the State Primary Health Care Boards and other relevant ministries to fast-track program implementation.
 - iv. Work in close coordination and collaboration with development partner to resolve key RMNCAH+N challenges and drive completion of quick wins to enhance integrated PHC service provision.
 - v. Build strong relationships with government officials and development partners at all levels.
 - vi. Work closely with the other arm of the immunization plus and synergize efforts and integrate where applicable.
6. Resource Mobilization and Partnerships
- i. Support resource mobilization and partner coordination efforts of the national and state RMNCAH+N coordination platforms.
 - ii. Engage and collaborate with development partners to enhance donor coordination and resource mapping for RMNCAH+N
7. Capacity Development
- i. Support the development of technical documents and proposals as would be assigned by the RMNCAH+N Program Manager.
 - ii. Provide technical mentoring support to key NPHCDA RMNCAH+N staff in the design and implementation of RMNCAH+N strategies and interventions specifically around

- project management, planning, budgeting, performance management processes, data collection and analysis, reporting and monitoring and evaluation.
- iii. Support development and/or review of national strategies and frameworks for RMNCAH+N.
 - iv. Provide technical assistance to NEMCHIC on identification, development and/or adaptation of guidelines, training materials and manuals.
8. Evidence and Knowledge Development
- i. Support the incorporation of evaluation results and lessons learned in updating strategies and approaches to improve the effectiveness of national RMNCAH+N programs and interventions.
 - ii. Provide support in developing a prioritized national RMNCAH+N operational research agenda.
 - iii. Support the State to conduct routine diagnostic (data) analysis of the PHC services and develop a monitoring plan for implementation.
 - iv. Ensures alignment of Key Performance Indicators (KPIs) to critical success factors (CSFs) working with team members to ensure that these objectives are realized.
9. Adhere to the key values and relevant codes as enshrined within NPHCDA.
10. Function independently and flexibly
11. Carry out any other responsibility as assigned by the IMPACT Project Manager.

E. Selection Criteria:

Essential Minimum Qualifications:

- i. Advanced University degree in any of the following – Public Health, Medicine, or other related fields. The degree must be directly related to the substantive area identified in the roles and responsibilities of the post.
- ii. More than 7 years of relevant and increasingly responsible experience in managing and implementation of RMNCAH+N programs and interventions, respectively.
- iii. Demonstrable experience working with government and partner agencies at national level is an asset.
- iv. In-depth understanding of the Nigerian health system and RMNCAH+N policies and programs.
- v. Experience in implementation of RMNCAH+N interventions.
- vi. Experience in providing technical support and assistance on RMNCAH+N programs coordination and implementation.
- vii. Demonstrated capacity to effectively coordinate organizations with good expertise in navigating and strengthening relationships among government and development organizations.

- viii. Extensive experience with large scale health systems strengthening interventions, particularly in the public sector.
- ix. Significant experience in strategic planning, organizational development, change facilitation and process management in the health sector.

Desirable Qualifications and Competencies:

- i. Strong team spirit, managerial, problem-solving skills, and ability to work in a high-pressure environment.
- ii. Strong diplomatic and interpersonal relationship skills.
- iii. Ability to travel within Nigeria without limitation.
- iv. Strong analytical skills and a high level of technical proficiency with Microsoft Word, Excel and PowerPoint.
- v. Should have advance skills in operating basic scientific or research e.g., Epi Info, Open Epi, SPSS, Stata skills, etc.
- vi. Basic knowledge in downloading and analysis of data from basic program tools and platforms such as DHIS2, ODK, etc.
- vii. Fluency in English (verbal and written)
- viii. Fluency in local language spoken in vast majority of IMPACT states is an additional advantage.

F. Terms of Engagement

- i. **Time Frame:** The engagement will be full-time, for an initial period of two years, with an opportunity for review of performance and possible renewal subject to satisfactory quarterly (every three months) performance review.
